

research, the researchers can focus on elements included in demographic factors such as age, gender, and education because there is no research related to this. Researchers can start with the research question of whether these elements also affect community participation in natural disaster management in Indonesia. The researchers should also add to various databases, followed by a more comprehensive elaboration of the results in the hope that these results can be applied practically in disaster management activities.
