

# PERAN DINAS SOSIAL, PEMBERDAYAAN PEREMPUAN DAN PERLINDUNGAN ANAK KABUPATEN GUNUNGKIDUL DALAM PENANGANAN ANAK KORBAN KEKERASAN SEKSUAL

## INTISARI

Penulisan hukum ini bertujuan mengetahui dan mengkaji peran Dinsos PPPA Kabupaten Gunungkidul dalam menangani Anak Korban kekerasan seksual dan kendala yang dihadapi dalam melakukan penanganan tersebut.

Jenis penelitian dalam penulisan hukum ini adalah penelitian normatif empiris dan sifat penelitian deskriptif. Jenis data dalam penelitian ini menggunakan data primer yang diperoleh dari wawancara dengan narasumber dan responden, serta data sekunder yang diperoleh dari studi kepustakaan. Data yang diperoleh dalam penelitian ini dianalisis menggunakan metode kualitatif.

Berdasarkan hasil penelitian diperoleh kesimpulan bahwa penanganan Anak Korban kekerasan seksual oleh Dinsos PPPA dilakukan oleh UPT PPA Kabupaten Gunungkidul dan Peksos Rehabsos dengan pemberian layanan berupa layanan pengaduan, layanan pendampingan hukum, layanan pendampingan psikologis, layanan penjangkauan korban, layanan rehabilitasi dan reintegrasi sosial, layanan rumah aman, dan layanan rujukan kesehatan. Namun, pada pelaksanaannya terdapat berbagai kendala yang dihadapi Dinsos PPPA Kabupaten Gunungkidul yaitu terbatasnya sumber daya manusia, kurangnya sarana dan fasilitas serta stigma negatif masyarakat Kabupaten Gunungkidul terhadap anak korban kekerasan seksual.

CHILDREN VICTIMS OF SEXUAL HARRASMENT**

***ABSTRACT***

*This legal writing aims to identify and examine the role of Department of Social, Women's Empowerment and Child Protection of Gunungkidul Regency in dealing with child victims of sexual violence and the obstacle they face in carrying it out.*

*This legal research belongs to the type of normative-empirical legal research and presented descriptively. The type of data in this study uses primary data obtained from interviews with informant and respondents, as well as secondary data obtained from literature studies. The data obtained in this study were analyzed using qualitative methods.*

*Based on the results of research, it was concluded that the handling of children victims of sexual violence by the Department of Social, Women's Empowerment and Child Protection of Gunungkidul Regency was carried out by the Technical Unit of Child Protection and Rehabsos's Social Workers by providing services in the form of complaint services, legal assistance services, psychological assistance services, victim outreach services, social rehabilitation and reintegration services and shelter services. However, in its implementation, there are various obstacle faced by Department of Social, Women's Empowerment and Child Protection of Gunungkidul Regency. The obstacles are lack of human resources, lack of facilities and amenities and also the negatives stigma of Gunungkidul's people about Sexual violence's victims.*
