Penelitian ini bertujuan untuk mengetahui pelaksanaan kinerja dan bentuk peningkatan kinerja Badan Pengawas Pemilu Kota Surakarta dalam memutus sengketa proses pemilu sebagai upaya memenuhi keadilan Pemilu. Bawaslu memiliki fungsi mengadili Pemilu menimbulkan pertanyaan apakah kinerja Bawaslu mampu menerapkan prinsip peradilan yang mengedepankan nilai-nilai dasar hukum. Perlu diketahui pelaksanaan kinerja dan bentuk peningkatan kinerja anggota Bawaslu. Penelitian hukum yuridis-empiris dengan data primer yang dikumpulkan dari Kantor Bawaslu Kota Surakarta. Hasil penelitian menunjukkan kinerja dan bentuk peningkatan kinerja anggota Bawaslu Kota Surakarta dalam memutus penyelesaian sengketa proses pemilu sebagai upaya pemenuhan keadilan pemilu ditinjau dari peraturan perundang-undangan sudah sesuai Perbawaslu Nomor 9 Tahun 2022 dan Keputusan Bawaslu Nomor 173/KP. 01/K1/05/2023 tentang Rekrutmen Anggota Bawaslu Kota Surakarta. Dari kondisi empiris, kinerja anggota Bawaslu Kota Surakarta belum didampingi peningkatan kinerja dan sertifikasi. Peningkatan kinerja dilakukan melalui perbaikan sistem rekrutmen anggota, realisasi pengaturan secara teknis mengenai peningkatan kinerja anggota melalui penyelenggaraan pendidikan dan pelatihan penanganan sengketa proses Pemilu.

Abstract

This research aims to determine the implementation of performance and forms of improving the performance of the Surakarta City Election Supervisory Board in deciding election process disputes as an effort to fulfill election justice. Bawaslu's function is to adjudicate elections, raising questions about whether Bawaslu's performance is able to apply judicial principles that prioritize basic legal values. It is necessary to know the implementation of performance and forms of improving the performance of Bawaslu members. Juridical-empirical research with primary data collected from the Surakarta City Bawaslu Office. The results of the research show that the performance and forms of improving the performance of Surakarta City Bawaslu members in deciding the resolution of election process disputes as an effort to fulfill election justice in terms of statutory regulations are in accordance with Perbawaslu Number 9 of 2022 and Bawaslu Decree Number 173/KP. 01/K1/05/2023 concerning Recruitment of Surakarta City Bawaslu Members. From empirical conditions, the performance of Surakarta City Bawaslu members has not been accompanied by performance improvements and certification. Performance improvement is carried out through improvements to the member recruitment system, realization of technical arrangements regarding improving member performance through the provision of education and training in handling election process disputes
