



Keempat, hasil penelitian menunjukkan keterlibatan model relasi lain selain pasangan setara (e.g., berbagi komunal, pemeringkatan kekuasaan). Oleh karena itu, penelitian selanjutnya disarankan untuk mengembangkan skala yang mengukur keempat model teori relasional tersebut dan mengujinya menggunakan SR-SEM. Langkah ini dapat menjadi bentuk pengujian empiris dan memperluas cakupan penelitian sebelumnya.

## Kesimpulan

Penelitian ini menemukan bahwa skala ekualitas relasi pertemanan yang dikembangkan berdasarkan teori pasangan setara memiliki validitas konten dan konstruk yang kuat, sebagaimana dibuktikan melalui analisis IRT dan CFA. Hasil analisis SR-SEM juga menunjukkan dinamika ekualitas relasi pertemanan di tingkat individu dan diadik, memberikan pemahaman mendalam mengenai hubungan interpersonal dalam konteks pertemanan. Dengan demikian, penelitian ini menawarkan pendekatan yang lebih komprehensif untuk mengeksplorasi dinamika relasi pertemanan melalui metode mutakhir
