INTISARI

Penelitian ini bertujuan untuk mengetahui dan menganalisis peran Kantor Wilayah Kementerian Hukum dan Hak Asasi Manusia Daerah Istimewa Yogyakarta dalam mendukung pelaksanaan pengawasan Notaris oleh Majelis Pengawas Daerah Notaris Kabupaten Sleman, pelaksanaan pengawasan Notaris oleh Majelis Pengawas Daerah Notaris Kabupaten Sleman atas dukungan Kantor Wilayah Kementerian Hukum dan Hak Asasi Manusia Daerah Istimewa Yogyakarta, serta kendala dan solusi pelaksanaan pengawasan Notaris oleh Majelis Pengawas Daerah Notaris Kabupaten Sleman atas dukungan Kantor Wilayah Kementerian Hukum dan Hak Asasi Manusia Daerah Istimewa Yogyakarta.

Penelitian ini bersifat normatif-empiris. Data yang digunakan adalah data primer yang diperoleh dari penelitian lapangan dan data sekunder yang diperoleh dari studi pustaka, kemudian dianalisis secara kualitatif. Hasil analisis data disajikan secara deskriptif kualitatif.

Hasil dari penelitian ini menunjukkan: 1) Peran Kantor Wilayah Kementerian Hukum dan Hak Asasi Manusia Daerah Istimewa Yogyakarta dalam mendukung pelaksanaan pengawasan Notaris oleh Majelis Pengawas Daerah Notaris Kabupaten Sleman belum sepenuhnya sesuai dengan Peraturan Menteri Hukum dan Hak Asasi Manusia Republik Indonesia Nomor 40 Tahun 2015 Tentang Susunan Organisasi, Tata Cara Pengangkatan Anggota, Pemberhentian Anggota, dan Tata Kerja Majelis Pengawas, dan Peraturan Menteri Hukum dan HAM Republik Indonesia Nomor. 2) Pelaksanaan pengawasan Notaris oleh Majelis Pengawas Daerah Notaris Kabupaten Sleman belum dapat dilaksanakan sepenuhnya karena masih terdapat Notaris yang belum diperiksa. 3) Masih terdapat kendala dan diperlukan solusi dalam pelaksanaan pengawasan Notaris oleh Majelis Pengawas Daerah Notaris Kabupaten Sleman.

THE ROLE OF YOGYAKARTA REGIONAL OFFICE OF MINISTRY OF LAW AND HUMAN RIGHTS IN SUPPORTING THE SUPERVISION OF NOTARIES IMPLEMENTED BY REGIONAL NOTARY SUPERVISORY BOARD OF SLEMAN REGENCY

ABSTRACT

This research was aimed to discover and analyze the role of Yogyakarta Regional Office of Ministry of Law and Human Rights in supporting the supervision of notaries implemented by District Notary Supervisory Board of Sleman, the supervision of notaries conducted by District Supervisory Board of Sleman with the support from Yogyakarta Regional Office of Ministry of Law and Human Rights as well as the obstacles and solutions of the supervision of notaries conducted by District Notary Supervisory Board of Sleman with the support from Yogyakarta Regional Office of Ministry of Law and Human Rights.

This research was a normative-empirical study. The data used were primary data acquired from field study and secondary data obtained from literature study which then analyzed in qualitative manner. The results of data analysis were presented in descriptive-qualitative manner.

The results of this research have indicated that 1) the role of Yogyakarta Regional Office of Ministry of Law and Human Rights in supporting the supervision of notaries conducted by District Notary Supervisory Board of Sleman has not been fully in accordance with The Regulation of Ministry of Law and Human Rights of Republic of Indonesia No.40/2015 concerning the Structure of Organization, Membership Appointment Procedure, Membership Discharge Procedure, and Working Procedure of Supervisory Board (State News of Republic of Indonesia No.1787/2015), 2) the supervision of notaries conducted by District Notary Supervisory Board of Sleman has not been able to be utterly performed due to some notaries who are yet to be investigated, 3) obstacles were found and solutions are required in the supervision of notaries conducted by District Notary Supervisory Board of Sleman
