**INTISARI**

Tesis ini bertujuan untuk mengetahui pelaksanaan ketentuan Magang Bersama dalam rangka Menciptakan Notaris yang profesional, terampil, berkepribadian baik, dan berahlak mulia di wilayah Sumatera Selatan serta mengetahui peranan Organisasi Notaris (Ikatan Notaris Indonesia) dalam melakukan penegakan aturan terkait Magang Bersama dalam rangka menciptakan Notaris yang profesional, terampil, berkepribadian baik, dan berahlak mulia di wilayah Sumatera Selatan.

Penelitian ini lebih menekankan pada jenis penelitian normatif empiris yang menggunakan data sekunder dan data primer. Tahap pertama yang dilakukan adalah meneliti data sekunder terlebih dahulu kemudian dilanjutkan dengan penelitian data primer. Data sekunder diperoleh dengan jalan penelitian kepustakaan dimana mengkaji dari bahan hukum primer, bahan hukum sekunder, dan bahan hukum tersier. Data primer diperoleh dengan cara penelitian lapangan, dengan mewawancarai responden dan narasumber. Data yang sudah terkumpul baik data sekunder maupun data primer dianalisis dengan metode kualitatif, dan disajikan secara deskriptif.

Pelaksanaan Magang Bersama dalam rangka menciptakan Notaris yang profesional, terampil, berkepribadian baik, dan berahlak mulia di Sumatera Selatan selalu berpedoman dan telah sesuai dengan Peraturan Perkumpulan Ikatan Notaris Indonesia tentang Magang. Peranan Organisasi Notaris (Ikatan Notaris Indonesia) dalam melakukan penegakan aturan terkait Magang Bersama sampai saat ini telah terlihat secara signifikan karena Pengurus Wilayah Ikatan Notaris Indonesia Propinsi Sumatera Selatan dalam menyelenggarakan kegiatan Magang Bersama selalu rutin dan terjadual serta melakukan pembinaan dan pengawasan dalam pelaksanaan kegiatan Magang Bersama.

**ABSTRACT**

This thesis aimed to determine the implementation of the rules of Joint Internship in creating professional, skilled, good attitude, and well manner notary in South Sumatera as well as to find out the role of Notary Society (*Ikatan Notaris Indonesia*) in enforcing the rules regarding Joint Internship in creating skilled and professional Notary in South Sumatera.

This research emphasized more on the type of empirical normative research that used primary and secondary data. The first step was carried out by studying secondary data then continued with primary data. Secondary data was obtained through library research by studying primary, secondary, and tertiary legal materials. Primary data was obtained through field research by interviewing the respondents and interviewees. The data that had been collected both primary and secondary data were analyzed using qualitative method, and presented descriptively.

The Implementation of Joint Internship in creating professional, skilled, good attitude, and well manner Notary in South Sumatera was always based on and in line with the rules that had been determined in the Rules of Indonesian Notary Society concerning Internship. The role of Notary Society of *Ikatan Notaris Indonesia* in this term was The Regional Board of South Sumatera in enforcing the rules regarding Joint Internship that was always be routine and scheduled as well as guiding and supervising in the implementation of Joint Internship program.
