Latar Belakang: Pelayanan di rumah sakit memiliki berbagai macam risiko yang membahayakan keselamatan dan keamanan. Sejak berdirinya di tahun 2008 RSUD Kabupaten Konawe Utara belum melaksanakan akreditasi. Akreditasi menjadi hal yang mendesak dan wajib dilaksanakan untuk memberikan standar operasional rumah sakit, fasilitas kesehatan, meningkatkan mutu pelayanan, menilai perkembangan dari pelayanan, kondisi bangunan fasilitas fisik, serta keselamatan dan keamanan.

Tujuan: Menganalisis persiapan akreditasi rumah sakit pada aspek keselamatan dan keamanan sesuai standar MFK 2012 di RSUD Kabupaten Konawe Utara.

Metode: Penelitian ini adalah penelitian kualitatif dengan rancangan deskriptif. Penelitian ini mendeskripsikan hasil wawancara persiapan akreditasi rumah sakit sesuai standar MFK 2012 dengan menggunakan panduan instrument Komisi Akreditasi Rumah Sakit.

Hasil: RSUD Kabupaten Konawe Utara belum melaksanakan program keselamatan dan keamanan tetapi telah memiliki komitmen untuk menerapkan program keselamatan dan keamanan. Anggaran penyediaan fasilitas fisik akan disusun dan diajukan pada pembahasan anggaran di pemerintah daerah dan DPRD. Pemenuhan tenaga kesehatan khususnya tenaga K3RS akan dilakukan perekrutan tenaga yang ahli dan profesional serta komitmen untuk peningkatan sumber daya manusia melalui pelatihan K3RS. Pihaknya juga berencana menghadirkan tim kalibrasi untuk mengetahui kondisi alat-alat kesehatannya dan berencana membuat SOP terkait pemeriksaan fasilitas fisik. Pemenuhan kebutuhan fasilitas fisik di rumah sakit beberapa diantaranya telah tersedia dan beberapa masih dalam proses pengkajian.

Kesimpulan: Program keselamatan dan keamanan belum dilaksanakan. Persiapan anggaran penyediaan fasilitas fisik dan sumber daya manusia telah direncanakan. Persiapan pemeriksaan fasilitas fisik dan program penyediaan fasilitas fisik akan menghadirkan tim kalibrasi sedangkan pemenuhan kebutuhan fasilitas fisik beberapa telah tersedia serta beberapa masih dalam proses pengkajian.

**ANALYSIS OF HOSPITAL ACCREDITATION PREPARATION
ON SAFETY AND SECURITY ASPECTS
ACCORDING TO THE MFK STANDARD 2012
AT REGIONAL GENERAL HOSPITAL KONAWE UTARA**

ABSTRACT

Background: Hospital service has a variety of risks that endanger safety and security. Since its establishment in 2008 Regional General Hospital Konawe Utara has not implemented accreditation yet. Accreditation becomes urgent and must be implemented to provide operational standards of hospitals, health facilities, improve service quality, assess the progress of services, building conditions physical facility, as well as safety and security.

Objective: Analyze hospital accreditation preparation on safety and security aspects according to MFK 2012 standard at Regional General Hospital Konawe Utara.

Method: This is a qualitative research with descriptive design. This research describes the result of hospital accreditation preparation according to MFK 2012 standard by using instrument guide of Accreditation Committee of Hospital.

Finding: Regional General Hospital Konawe Utara has not implemented yet a safety and security program but has committed to implementing it. The budget for the provision of physical facilities will be arranged and submitted to the budget discussions at the local government and Regional Representative Council. The fulfillment of health personnel especially Occupational Safety and Health of Hospital personnel will be recruited skilled and professional personnel as well as the commitment to increase human resources through Occupational Safety and Health of Hospital training. The party also plans to bring a calibration team to find out the condition of health equipment and plans to make Standard Operating Procedure related to physical facility inspection. The fulfillment of the need for physical facilities in hospital, some of which are already available and some are still under review.

Conclusion: Safety and security programs have not been implemented yet. Preparation of budget for the provision of physical facilities and human resources has been planned. Preparation of physical facility inspection and physical facility provision program will provide a calibration team while fulfillment of several physical facilities needs are available and some are still in review process.
