PENEGAKAN HUKUM TERHADAP TINDAK PIDANA PERJUDIAN MELALUI INTERNET (*INTERNET GAMBLING*)

Perkembangan teknologi memberikan dampak besar dalam kehidupan manusia. Pekembangan teknologi informasi membuat modus operandi tindak pidana perjudian semakin berkembangan. Pelaku perjudian tidak perlu bertatap muka secara langsung untuk melakukan kegiatan perjudian, namun dapat menggunakan sarana teknologi informasi.

Berdasarkan uraian diatas, kemudian muncul permasalahan yang akan diangkat dalam penulisan hukum ini yaitu bagaimana penegakan hukum dalam upaya penanggulangan yang dilakukan oleh Polisi, Penuntut Umum, dan Hakim dalam tindak pidana perjudian melalui internet (*internet gambling*), dan bagaimana upaya mengatasi hambatan yang dilakukan dalam penegakan hukum tindak pidana *internet gambling*. Permasalahan diatas bertujuan untuk mengetahui upaya Polisi, Penuntut Umum, dan Hakim dalam melakukan penanggulangan tindak pidana *internet gambling*.

Kajian penelitian menggunakan jenis penelitian normatif dan empiris. Hasil analisa yang dapat disimpulkan adalah penegakan hukum dilakukan dengan penerapan pasal perjudian dalam KUHP dan penanggulangan dilakukan dengan upaya non penal dan penal. Upaya penanggulangan tindak pidana *internet gambling* yang dilakukan oleh Aparat Penegak Hukum belum optimal karena tindak pidana *internet gambling* masih banyak terjadi.

ABSTRACT

THE LAW ENFORCEMENT ON THE CRIMINAL ACT OF INTERNET GAMBLING

Technological developments gave a great impact in people's lives. The development of technology is inversely proportional to the development of the modus operandi of internet gambling. With the development of information technology the internet gambling offender doesn't need to face to face directly to conduct gambling activities, but may only use information technology.

Based on the description above, then come the problems which is raised in this law thesis which is how law enforcement in the response made by the police, prosecutor, and judge and how barriers and efforts experienced by the police, the prosecutor, and the judge in the prevention of internet gambling. The raising of the problems as written above have the objectives to know the means undertaken by police, prosecutor, and judge in handling the criminal act of internet gambling.

The type of this research is normative and empirical. The results of analysis that can be summed up in the writing of this law thesis is that the law enforcement carried out by the application of an article gambling in the penal code and prevention efforts conducted by non penal and penal. Efforts to control internet gambling committed by law enforcement authorities have not been sufficiently proved by the interent gambling activities that still happening untill now.
