INTISARI

Badan Penyelenggara Jaminan Sosial (BPJS) Kesehatan resmi menyelenggarakan program jaminan kesehatan nasional sejak 1 Januari 2014, Dalam pelaksanaannya, BPJS Kesehatan bekerjasama dengan fasilitas kesehatan. Balai Pengobatan PKU Karangasem Paciran merupakan salah satu fasilitas kesehatan yang bekerjasama dengan BPJS Kesehatan. Perjanjian kerjasama pemberian pelayanan jaminan kesehatan antara BPJS Kesehatan dengan Balai Pengobatan PKU Karangasem Paciran tidaklah selalu berjalan dengan baik. Baik dari pihak BPJS Kesehatan maupun Balai Pengobatan PKU Karangasem Paciran pernah melakukan wanprestasi. Kedua belah pihak dalam menyelesaikan wanprestasi mengedepankan cara musyawarah untuk mufakat namun tidak menutup kemungkinan akan diterapkan sanksi tegas apabila wanprestasi tetap terulang.

ABSTRACT

Social security agency (BPJS) for health officially has held national health insurance program since 1st January 2014. In practice, social security agency (BPJS) for health is collaborating with some health facilities. Clinic PKU Karangasem Paciran is one of the health facilities which is collaborating with social security agency (BPJS) for health. The implementation of the letter of agreement for the provision of national health insurance services between social security agency (BPJS) for health with clinic PKU Karangasem Paciran doesn't always go well. Each party ever did a failure. Both of parties have agreed that negotiation is the best way to solve their problems, though it doesn't rule out the possibility that strict penalty will be applied if breach of contract remain occur.
