Tujuan dilakukannya penelitian ini adalah menganalisis peranan organ yayasan Daar El-Bayan Santri dalam pelaksanaan perjanjian pendidikan anak di Pondok Pesantren Al-Bayan Kabupaten Lebak, Provinsi Banten dan menganalisis akibat hukum dari intervensi pembina yayasan Daar El-Bayan Santri dalam perjanjian pendidikan anak di Pondok Pesantren Al-Bayan Kabupaten Lebak, Provinsi Banten.

Penelitian ini tergolong jenis penelitian yuridis empiris dan yuridis normatif yang menggunakan sumber data primer maupun sekunder dengan menggunakan pengumpulan data dari wawancara terstruktur dan studi kepustakaan, sedangkan sifat penelitian ini merupakan penelitian diskriptif, teknik pengambilan sampel melalui Purposive Sampling dan subyek yang diambil dalam penelitian ini sebanyak 9 responden, kemudian data yang diperoleh dari studi kepustakaan dan lapangan dalam penelitian diolah untuk menyederhanakan dalam analisis diskriptif kualitatif.

Berdasarkan hasil penelitian serta pembahasan, penulis menyimpulkan bahwa peranan organ yayasan Daar El-Bayan Santri dalam pelaksanaan perjanjian pendidikan anak di Pondok Pesantren Al-Bayan Kabupaten Lebak, Provinsi Banten diantaranya adalah: pembina menetapkan dan mengesahkan perjanjian pendidikan anak, pengurus menjalani dan mengurus perjanjian pendidikan anak, pengawas mengetahui dan mengawasi perjanjian pendidikan anak, dan akibat hukum dari intervensi pembina yayasan Daar El-Bayan Santri dalam perjanjian pendidikan anak di Pondok Pesantren Al-Bayan Kabupaten Lebak, Provinsi Banten adalah Pembina menjadi pihak dalam perjanjian pendidikan anak di Pondok Pesantren Al-Bayan, berdasarkan Pasal 1338 KUH Perdata bahwa kedudukan Pembina mengintervensi dalam perjanjian pendidikan anak, Pembina ikut bertanggung jawab atas kerugian yang terjadi dalam pelaksanaan perjanjian pendidikan anak.
